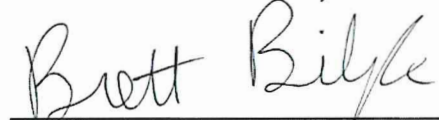

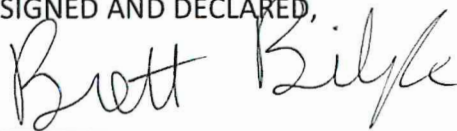
Question 3:

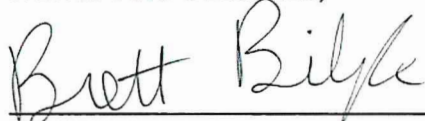
