# NOTICE OF APPEAL

## Election Law of Bigstone Cree Nation

Section 15.2(a)

a Candidate was guilty of a Corrupt Election Practice or benefited from and consented to a Corrupt Election Practice; or

any other circumstance, event or action which improperly, and materially and directly affected the conduct and outcome of the Election.

I, Jason Noskiye, am appealing the January 4, 2026 By-Election of Chief based on the facts that affected the outcome of this Bigstone Cree Nations 2026 Election of January 4, 2026.

#1) What is the online verification process that onefeathers uses? No where in the election code is it written that Bigstone Cree Nation has passed a motion for online voting to be allowed and there also is no referendum with Bigstone Cree Nations members to vote and make a decision to follow through with online voting. Many Bigstone members had a difficult time casting their votes and many of them did not, which would change the number drastically and if other individuals voting numerous times, as many members found out they received emails that they voted up to 3 times in a confirmed email, so many factors on the final number on outcomes of this election.

#2) Fort St. John polling station was not included for a polling station for election in 2026. This could have been a huge factor for this election as well. Fort St John polling station has always been a polling station in previous BCN elections.

#3) Interference at a polling station in Edmonton Ref 10.11 (a) Election Code. [REDACTED]

[REDACTED] was influencing people/voters to vote for Silas, Refer to statement given by Vina Baron. A full Bigstone Cree Nation Member.

So many things went wrong in this by-election and requesting a revote, without the online voting and to include Fort St John as a polling station.
